Xin guidance techniques are impeccable; she acknowledges feelings, use of body positioning (eye-level) having open body language, appropriate voice volume. She brings her expertise into every single interaction with children (books, playing, supervision, interaction setting up environment). She welcomes and respects all cultural, religious divers

In my opinion relationships is the most essential part of Early childhood education. I believe forming close bonds is a super-power of Xin's; she excels at making all children, families, staff feel seen, valued, and respected.

Principal 4

We work in partnerships with families, supporting them in meeting their responsibilities for their children.

There was a child who had a difficult time at rest-time despite a full morning playing outside. Her parents really liked her to nap; but we weren't always able to get her to nap because of her need to roll and flip on her bed. We suggested to her parents that they bring us a weighted blanket to try, and it worked like a charm. She would settle so quickly.

Principle 5

We establish and maintain respectful partnerships with colleagues, allied professionals, community partners, and decision-makers to support the well-being of children and their families.

Xin was incredibly professional at all times with Little Jewels staff, TRU professors, she told me about attending ECE awareness rally's on weekends, and taking professional development.

A new family enrolled at our centre, and she was fluent in Taiwanese language - but her children were not, the mom asked if Xin could speak their language to ~~the~~ her children. Xin was always intrigued by my Secwepme language and culture.

Xin brings a wealth of knowledge to our field. For example, her image of the child is one that demonstrates respect for their competence. She asks mentor lots of questions to expand her learning.

I love how Xin arrives in the morning, she is well-rested dressed appropriately. She eats nutritious meals and drinks lots of water. I believe Xin also knows the value of self-care ie. making time for friends/family to rest and re-charge.

This goes without saying, she is warm, welcoming, and polite. She asks plenty of questions to try to understand, and she is accountable and a reliable educator.
